## Act Now to End the Genocide in Gaza

In mid-August, the Biden administration notified Congress of its intent to authorize massive new arms sales to the Israeli government, a total of \$20 billion dollars of the same kinds of weapons that have already killed more than 40,000 people in Gaza since October 7, 2023; triggered a famine; destroyed homes, hospitals, and schools; and caused the outbreak of a long-eradicated disease, polio. This has done nothing to bring home the hostages or increase long-term security for people in the region. It has, instead, brought the region – and the world – to the brink of a much wider war.

In the past five days, the Israeli government has also mounted an assault on the West Bank, killing an estimated 600 people, according to the United Nations Humanitarian Affairs Office.

The clear goal of the Netanyahu government is the destruction of an entire population, using U.S. weapons. <u>Make no mistake: this could not continue without our government's support.</u>

According to Win Without War (<a href="https://winwithoutwar.org">https://winwithoutwar.org</a>), this most recent arms package includes:

- \$18.8 billion for 50 F-15 fighter jets and related equipment.
- \$774 million for 32,739 120mm tank cartridges.
- § \$61 million for 50,000 high-explosive mortar cartridges; and
- § \$262 million for 6,500 Joint Direct Attack Munitions (JDAMs).

This is not yet a "done deal," however. The process to sell this next shipment of \$20 billion of weapons to Israel is not yet complete. The Senate has between 10 and 15 days to register disapproval by calling for a <u>Joint Resolution of Disapproval (JRD)</u>. This would stop, or pause, the sale by requiring the Senators to debate then vote to approve, or not, this sale. <u>Just one Senator introducing a JRD will trigger this process</u>. If no Senator introduces a JRD within that time frame, the sale is automatically approved.

Sen. Bernie Sanders, (Independent, VT) has stated that he will introduce such a resolution. Please call his office at 202-224-5141, no matter where you live, to show your support and encouragement for this action.

Then, go to your own Senators and demand that they vote against the sale. However unlikely they are to act, they need to hear the message loud and strong that their constituents will not stand for their complicity in this genocide any longer.
